Now that we have your attention, we'd like to inform you about the **Excess Homeowner Grant for Self Taxing First Nations** in the Province of British Columbia.

Under Section 14 of the *Indian Self Government Enabling Act* a band that has elected for self-taxation can receive a grant in place of the benefits that are payable under the *Home Owner Grant Act*. In order to receive the grant, the program you administer should mirror that of the provincial homeowner grant.

Certificate in Public Administration - First Nations Taxation

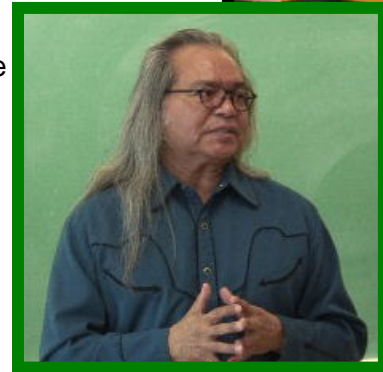

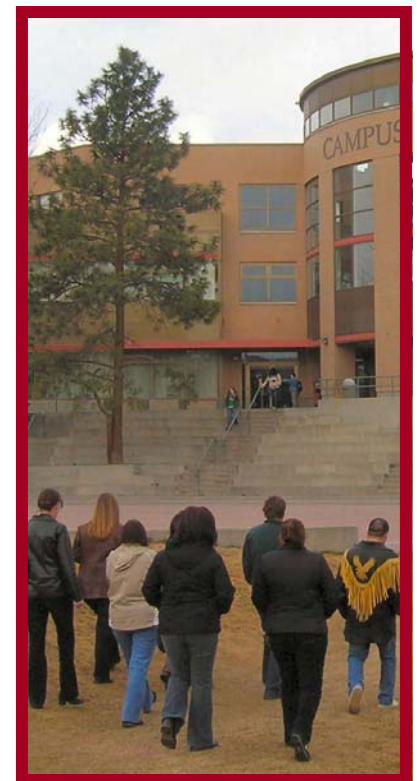


The Certificate Program Course Requirements include:
